### **MOTIVE**

Sri Venkateswara College of Engineering and Technology under the management of Vikas Educational Society is established in 2008 and it offers B.Tech, M.Tech and MBA programs. The primary aim of this policy is to provide the financial assistance to the economically backward students.

### **SCOPE**

The purpose is to establish and formalizes the fee waiver policy in Hostel fee or Bus fee or Tuition fee for poor students for all programs provided by Sri Venkateswara College of Engineering and Technology under the management of Vikas Educational Society. The scheme will support female students, SC, ST students, economically backward students in pursuit of education. It is important to note that this policy does not define the admission criteria, such criteria are distinct and are communicated through separate admission notification for each academic year.

### **POLICY STATEMENT:**

In this policy Rs.10000-15000 will be waived for the students in their Hostel fee or Bus fee or in Tuition fee. As an incentive to registered students, the policy reduces the financial burden by offering them a discount equivalent to the specified amount on the specified fees.

### **PROCEDURE**

Among any students who from financially weaker section or students those have performed well in their previous examination shall be eligible for scholarship.

### **STUDENT ETIQUETTE**

The tuition fee or bus fee or the hostel fee is an exemption applies to the entire academic year during the duration of their study offered by the college. This benefit is contingent upon the students maintaining good behavior within both the hostel and college premises, as well as consistently upholding satisfactory
