### SUSPENSION OR DISMISSAL OF STUDENTS FROM THE COLLEGE

## UNDERTAKING FROM STUDENTS/ PARENTS WITH REGARD TO PREVENTION OF RAGGING PENALTY FOR RAGGING IN THE PROVISIONS OF ACT OF ANDHRA PRADESH PROHIBITION OF RAGGING ACT, 1997 (ACT 26 OF 1997) IN EDUCATIONAL INSTITUTIONS.

Ragging is an act which is likely to cause insult or annoyance or fear or apprehension or threat or intimidation or outrage or modesty or injury to students. This is a heinous crime which is uncivilized and demonic. There are instances when some psychologically weak students have committed suicides in engineering colleges because of ragging. Ragging is prohibited within or outside the educational institutions. The salient features of A.P state legislation and punishments for indulging in ragging are as follows.

EXTENT OF OFFENCE	PENALTY
Teasing or embarrassing or humiliating a student	Imprisonment of upto 6 months or a fine upto Rs.1,000/-or both.
Assault or use of criminal force or criminal intimidation	Imprisonment upto 1 year or a fine upto Rs.2,000/- or both.
Wrongful restraint or wrongful confinement or causing hurt.	Imprisonment upto 2 years or fine upto Rs.5,000/- or both.
Causing grievous hurt or kidnapping or abducting or committing unnatural offence.	Imprisonment upto 5 years with a fine upto Rs.10,000/-
Causing death or abetting suicide.	Imprisonment for life or for a term upto 10 years with fine upto rs.50,000/-.
