Sri Mudda Appanna, S/o Mudda Simhachalam, Regd.No. 5097331 is selected as Stipendiary Trainee Cadet Reserve Sub Inspector in APSP Battalions under rules framed in G.O.Ms.No.315, Home (Police, C) Dept., dated 13.10.1999. The selected Stipendiary Cadet Reserve Sub Inspector APSP Battalions should undergo (9) months induction training in **PTC, Ananthapuramu** and he will be paid an amount of **Rs.7500/-** per month as stipend during the training period from the date of commencement of training at **PTC, Ananthapuramu**. The trainee shall not be entitled for any other allowances or special pays etc., Subject to following conditions.

- i. He should report at **PTC, Ananthapuramu** on **25.05.2024 AN** without fail. The training will commence at **PTC, Ananthapuramu** from **26.05.2024 FN**.
- ii. If he fails to report on **26.05.2024**, his name will be deleted from the selection list as per the existing provisions. Further if any irregularity, misconduct or deficiency is detected the candidate trainee is liable to be terminated.
- iii. He should undergo 9 months induction training at **PTC, Ananthapuramu** and 9 months practical training.
- iv. He is not eligible for any kind of leave during the training period. Unauthorized absence shall be considered as misconduct calling for stern action. He shall be withdrawn from training and struck off from the Roll for unauthorized absence. Absence from training exceeding one month due to medical disability shall result in temporary medical invalidation requiring the trainee to undergo the training afresh with the next batch of trainee if he medically fit.
- v. He should also execute an Agreement Bond worth **Rs. 10,000/-** (Rupees Ten Thousand Only) on a Rs. 100 non-judicial stamp paper that he shall serve the department after training for a minimum period of (5) years from the date of actual appointment. In the event of discharge from training for any reason, he would forfeit the deposit amount as compensation towards training expenses and remuneration etc., received by him after joining the training.

- vi. He has to appear for the tests/examinations after completion of training both in indoor and outdoor subjects. If he fails to pass in one or more subjects, he will be retained for 2 more months in training institution and should appear the supplementary examination from the date of completion of final examination. If he failed in supplementary examination, he will be discharged from the training and will not be offered any appointment in the department.
- vii. He will also be liable for discharge from training for unsatisfactory progress work and indiscipline during the training period, without any notice and without paying any remuneration.
- viii. He should deposit an amount of Rs. 15000/- (Rupees Fifteen thousand only) as advance towards mess charges/ study materials etc., at PTC, Ananthapuramu.
- ix. He should also carry with him one pair of terry cot white pants, white full sleeves terry cot shirt, brown leather shoes and socks and (6) passport size color photographs. He should not carry bedding as PTC, Ananthapuramu will supply the same.
- x. The trainee shall not bring valuable articles like Gold Ornaments and costly mobiles phones to the training centre.
- xi. He should carry sufficient money to meet personal expenditure toward purchase of items like bucket, mug, personal toiletry items etc.
